Challenges of manual processes

Despite the availability of digital solutions, many AP teams continue to rely on manual invoice processing. This involves physically handling paper invoices, manually inputting data into systems, and cross-referencing information for accuracy. These labor-intensive methods lead to inefficiencies, higher error rates and compliance risks.

The Institute of Finance and Management (IoFM) reports that manual invoice processing carries an average error rate of 8-12%. This not only results in overpayments and missed discounts, but can also strain supplier relationships.

Furthermore, manual processing can cost up to \$30 per invoice and take up to 30 days to complete, compared to just \$3 to \$4 when automated—a significant difference in both efficiency and cost.

The burden of template-based OCR systems

Some organizations have taken initial steps toward automation through first-generation Optical Character Recognition (OCR) systems.

However, these first-generation OCR tools require the creation of templates for each vendor's invoice layout. This is time-consuming to set up and can lead to headaches in the longer term too. If vendors change their invoice formats, AP teams are forced into a continuous cycle of updating templates, significantly reducing the desired efficiency gains.

Compliance and security risks

Manual and first-generation OCR processes also expose AP teams to compliance and security risks. Financial data found in invoices must be handled securely, and improper management can lead to errors or unauthorized access.

Non-compliance with regulations such as Sarbanes-Oxley (SOX) and the General Data Protection Regulation (GDPR) can result in fines, reputational damage and loss of stakeholder trust.

Moving beyond traditional OCR with next-generation AI

Real-time fraud detection further enhances security by flagging suspicious invoice activity before it becomes a larger issue.

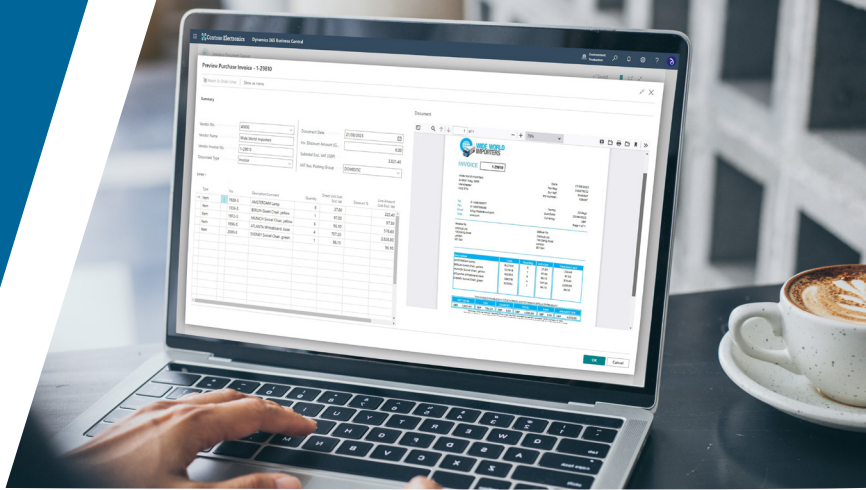
